

### SCOPE

Specific subsidies (as in ASCM Arts. 1 and 2), for marine wild capture fishing nad fishing related activities at sea

Take special care and exercise due restraint when subsidizing:

- > Vessels not flying that Member's flag
- Fishing unassessed stock

2 years peace clause

**Enforceable through** the WTO dispute settlement system

## Institutional Arrangements Committee on Fisheries Subsidies (Article 9)

Establishment of a \*
Committee on \*
Fisheries \*
Subsidies (Art. 9.1) \*

**Entry into force of the Agreement** 

- Established upon entry into force of the Agreement
- Composed of representatives from Member
- Elects its chair
- Meets at least twice a year
- Affords Members the opportunity to consult

### **Functions of the Committee**

### "Annual review"

- Reviews and reports on the implementation and operation of the Agreement
- Informs the Council for Trade in Goods of developments during the period covered by the review (Art 9.3)
- Review all information provided in accordance with Articles 3 and 8 (Art. 9.2)

### Periodic review

- Review the operation of the Agreement with a view to identifying all necessary modifications to improve its operation
- Where appropriate, the Committee may submit to the Council for Trade in Goods proposals to amend the text of the Agreement (Art. 9.4)



Not less than every two years

No later than five years after the date of entry into force of the Agreement and every three years thereafter

### **Technical Assistance and Capacity Building (Article 7)**

❖ Targeted technical assistance and capacity building assistance to developing country Members, including LDC Members, shall be provided for the purpose of implementation of the disciplines under this Agreement. In support of this assistance, a voluntary WTO funding mechanism shall be established in cooperation with relevant international organizations such as the Food and Agriculture Organization of the United Nations (FAO) and International Fund for Agricultural Development. The contributions of WTO Members to the mechanism shall be exclusively on a voluntary basis and shall not utilize regular budget resources.
