GLOBAL WTO AGREEMENT ON FISHERIES SUBSIDIES ENTERS INTO FORCE

At a special General Council meeting on 15 September, World Trade Organization (WTO) members celebrated the entry into force of the WTO Agreement on Fisheries Subsidies, which commits members to curbing billions of dollars in annual spending on the most harmful subsidies that contribute to the depletion of marine fish stocks. Hailing the Agreement as a “landmark for global trade governance”, Director-General Ngozi Okonjo-Iweala thanked WTO members for their commitment to protecting the livelihoods of fishing communities around the world. AUSTRALIA ELECTRONIC MONITORING STUDY TOUR STRENGTHENS PACIFIC FISHERIES MANAGEMENT

Australia recently hosted a study tour for fisheries leaders from seven Pacific Island nations to showcase its expertise in Electronic Monitoring (EM), a system using onboard cameras and sensors to improve data accuracy, compliance, and sustainability in tuna management. Supported by the Marine Stewardship Council (MSC) and the FAO, the visit highlighted how EM strengthens transparency, observer safety, and access to premium seafood markets. The initiative Under scores regional collaboration, offering Pacific nations practical pathways to sustainable fisheries and MSC certification.

VIETNAM DIVERSIFYING TUNA EXPORTS AS CANNED SEGMENT SHRINKS

Vietnam’s tuna industry is entering a pivotal transition as slowing growth in Western markets and supply pressures drive a shift toward value-added products and diversified markets. After a strong rebound in 2024, with exports reaching \$989 million, momentum has eased in the first half of 2025, totalling \$473 million. While this stability offers some resilience, it also underscores deeper challenges. Once reliant on bulk shipments to the US and EU, the sector is now being reshaped by a sharp contraction in the canned tuna segment, prompting greater emphasis on innovation and expanding into new markets.

INDIA HILSA EXPORTS TO INDIA REACH 63 TONNES IN TWO DAYS

On 18 September 2025, a second shipment of 26.35 MT of hilsa was sent to India through the Benapole Land Port, bringing total exports for the week to 63 MT. According to the Department of Fisheries (DOF), each hilsa weighed between 1.2 and 1.5 kilograms, with an export price of \$12.5 per kilogram (around Tk1,500). Export permissions were allocated under a government directive: one company was authorized to ship 50 MT, 25 companies were permitted 30 MT each, nine companies up to 40 MT each, and two companies up to 20 MT each.

Hong Kong

Hong Kong's live marine food fish imports fell 16.2% in volume and 17% in value in the first half of 2025, totaling 5 821 MT worth HK\$354 million. This follows a steep 33.1% annual decline in 2024. Unless there is a strong rebound in the second half, current trends are suggesting a full-year 2025 imports will remain below pre-2024 levels. Groupers, the dominant category, saw a 42.7% contraction, led by sharp drops in "other groupers," *leopard coral grouper*, and tiger grouper, while giant and green groupers were comparatively stable. Flowery grouper was the only species to post significant growth, indicating niche market recovery.

By contrast, other marine finfish imports grew by 33.5%, showing a clear shift toward more affordable species amid price-sensitive demand. The market continues to rebalance away from premium groupers toward value-oriented fish. Importers may benefit by focusing on competitively priced species, a sustained supply of stable-demand groupers, and watch for growth opportunities in flowery grouper.

Singapore

Singapore's live fish imports rose from 1 299 MT in 2022 to 1 724 MT in 2023 before easing to 1 567 MT in 2024, with values peaking at US\$31.3 million then slipping to US\$29.5 million, reflecting softer prices and a possible shift toward lower-value species. Malaysia remained the top supplier, followed by Indonesia, China, Vietnam, and Thailand, with growing demand for premium and sustainably sourced species (refer to the Fact Sheet on **page 23** on Singapore's annual imports of fish and fishery products).

In January-June 2025, live fish imports dipped 6.15% in value to US\$14.99 million while volumes held steady at 812 MT, signaling continued price sensitivity and slightly weaker demand.

Global frozen mackerel trade totaled 1.24 million MT in 2024, down 3.9% from 2023, with China and Norway leading supply. In the first half of 2025, China surged to 206 257 MT of exports (+34% year-on-year), while Norway held steady at 69 172 MT.

On the demand side, West Africa remained the largest market, led by Côte d'Ivoire and Nigeria, while Asia saw strong growth in Vietnam, Indonesia, and China. Overall, trade flows reflect shifting supply dominance toward Asia and resilient demand in price-sensitive African and Asian markets.

Singapore

Singapore's frozen fish (HS 0303) imports grew 13.3% year-on-year in the first half of 2025, reaching 13,345 MT, reflecting strong and stable demand. China and Malaysia led with a combined 28.9% share, with China showing nearly 45% growth, highlighting its competitiveness in quality, traceability, and pricing. Secondary suppliers such as Thailand, Norway, and Spain also contributed to a diversified sourcing base, supporting Singapore's food security and supply resilience.

World

During the first three quarters of 2025 (January–September), global demand for high-value, non-canned tuna remained stable across the key markets. In Asia - particularly Japan, the Republic of Korea, Thailand, and China - imports of this product category increased, primarily driven by sustained demand for *sashimi*-grade tuna fillets utilized in the foodservice sector, especially in Japanese cuisine establishments. In contrast, importers in North America and Europe focused on non-*sashimi*-grade tuna fillets and steaks, targeting both retail distribution channels and the hospitality industry.

Japan

This year, Japan experienced an unusually long spell of hot summer weather, lasting from June through September, with daytime temperatures consistently exceeding 30 degrees Celsius. The prolonged heat dampened consumer demand for raw seafood, including tuna across both the retail and catering segments of the *sashimi* trade.

Toyosu fish market

In September, the daily trading of fresh and frozen tuna has been slow in the auction market along with reduced catches of local bluefin and other tuna species. Imports of fresh air-flown tuna also declined, with the exception of limited quantities of the popular jumbo size bluefin from Boston (USA) and Canada, and Southern bluefin from Australia and New Zealand, causing price increases despite weakened demand from retail and restaurant end users.

USA

Summer demand for fresh and frozen tuna has been stable in the United States during July-August 2025, generating good sales opportunities in the retail and restaurant trade. Imports of the high-value non-canned tuna and fresh and frozen, were 20.4% higher in the USA at 59 120 MT during January-June 2025 in comparison with the same period in 2024. Cumulative imports also increased by 15% in July, reaching 68 879 MT, as distribution chains procured additional supplies in anticipation of higher import tariffs coming into effect in August 2025.

China

Demand for *sashimi* grade tuna continues to be good throughout the year from the large number of Japanese restaurants operating in China (estimated to be 125 000).

During January-July 2025, imports of fresh air-flown bluefin tuna, predominantly sourced from Spain, increased year-on-year from 479 MT in 2024 to 667 MT in 2025 reporting period. In the same period, imports of shelf-stable deep-frozen tuna fillets (mostly bluefin and bigeye) increased sharply from 184 MT to 534 MT, with principal supplies originating from Malta, Turkey, Korea Rep, Vietnam and Indonesia.

Raw Materials for Canning and Other Uses

Between July and September 2025, the FAD fishing closure remained in force across the Western and Central Pacific. Despite supply constraints, frozen skipjack prices held firm at approximately US\$1500/MT for deliveries to Thailand. Nevertheless, Thailand recorded a 19.23% year-on-year decline in cumulative imports of whole frozen tuna during January-August 2025, while imports of semi-processed cooked frozen loins increased by 32%, nearly reaching 7 000 MT.

In other markets, January-July 2025 import data reflected similar downward trends in whole frozen tuna: Spain (-1.35% at 73 180 MT), in the Philippines (-14.00% at 92151 MT) and in Ecuador (-23.4% at 47 000 MT).

Outlook

Supplies of frozen tuna for canning and other similar uses are likely to improve from October in the WCPO (Western and Central Pacific Ocean); which may lead to some softening in prices. Meanwhile, the high tariff imposed by the US government since August 2025, remains a matter of serious concern to Southeast Asia's tuna exporters. Its impact will also be felt on exports to Europe, and the Middle East markets. The recent increase in tariffs in the United States is anticipated to place downward pressure on demand for non-canned tuna products, potentially slowing growth in this emerging segment of the US market.

In its late September three-month outlook, the Japan Meteorological Agency (JMA) projected above-average daytime temperatures across the country in October, following what has been recorded as Japan's hottest summer. The delayed onset of autumn weather could disrupt inbound tourism patterns and exert downward pressure on sales in the HORECA sector, where seasonal demand shifts play a critical role in business performance.

SHRIMP

High tariffs ranging from 15% to 50% on US imports are in place from 27 August 2025. While its impact on shrimp imports is yet to be seen, shrimp farmers in South and Southeast Asia slowed down pond seeding since the third quarter of the year.

In South Asia, current supplies of farmed shrimp are low for export processing of frozen shrimp. Imports of frozen shrimp increased in Vietnam by 64.51% at 51 868 MT during January-July 2025 signaling reduced production locally; India and Ecuador were the main suppliers. In Southeast Asia and the Far East including China, supplies of fresh shrimp remain moderate for the domestic markets at stable prices.

In Ecuador, the export-oriented shrimp aquaculture industry continues to maintain its production target and reported a 15% rise in exports during January-July 2025.

Exports

Global shrimp exports were estimated to be 2.2 million MT during January-July 2025 which were 5.26% higher than the corresponding period in 2024. Among the top five exporting countries, Ecuador increased supplies by 15.4% at 829 064 MT followed by India (11.5% at 455 406 MT). Indonesia and China also posted gains, while Vietnam was the only major supplier to record a decline.

Imports

Global shrimp imports increased by 4.33% year-on-year in the first seven months of 2025, driven largely by strong US buying ahead of the high tariff implementation. However, imports in China were marginally low (-1.75%). Shrimp imports also increased in Europe and in the Asia Far East (Japan, Korea RP, Vietnam, Malaysia, Taiwan, and Singapore).

China

In 2025, China's monthly shrimp imports began recovering in May and sustained this momentum through August, with cumulative volumes posting a modest year-on-year increase of 0.35%. Imports increased during this period from Ecuador, Canada, Thailand, Vietnam and Argentina but declined from India.

In the export trade, China has maintained a positive trend since 2024, driven by exports of semi-processed and processed shrimp to key markets including Japan, Malaysia, Korea RP, and Taiwan. More than 50% of China's shrimp exports consists of value-added products.

USA

The US decision to impose reciprocal tariffs on shrimp exporters is reshaping global supply chains and forcing Asian producers such as India, Vietnam, Indonesia, to rethink trade strategies. India, the leading shrimp supplier to the US market, faces the most difficult scenario due to a 25% tariff that could rise to 50% under a new US executive order. Combined with existing antidumping and countervailing duties, the total tariff burden could exceed 58% for India in the US market.

Shrimp imports in the USA during the first-half of 2025 increased by 15% year-on-year, mainly associated with the high tariff from August 2025. It is important to highlight that, more than 50% of imported shrimp in the USA are semi-processed (raw frozen peeled shrimp) and processed products for which India is the leading supplier. During January-June 2025, imports of peeled shrimp in this market totalled 205 304 MT; India was the number one supplier (118 310 MT) followed by Ecuador, Indonesia and Vietnam.

Cumulative imports of shrimp in July were 15% higher year-on year at 487 069 MT. With a 39.63% share in this supply, India was the number one exporter in the market.

European Union

During the first 7 months of 2025, shrimp imports in the EU-27 increased by 11.2% year-on-year. The top five exporters were Ecuador, India, Vietnam, Greenland and Argentina. Supplies from the last two sources were sea-caught cold-water prawn. Imports from the top supplier Ecuador were significantly large and record high (+ 37.62% at 139 856 MT) during this period.

India, the second largest exporter to the EU after Ecuador, successfully increased exports to the Common Market during January-July 2025 (+24.8% at 50 805 MT) through its market diversification programme to combat the punitive tariff in the US market. However, so far, the supply gap between Ecuador and India remains wide in the EU market.

Although India has pursued market diversification, including a recent trade agreement with the United Kingdom, the tariff hike has dealt a significant blow to the country's fisheries sector.

Asia/Pacific

China remains the number one importer in the Asian and global shrimp trade. However, excluding China the ten import markets in the Asia/Pacific imported nearly 400 000 MT of shrimp during January-July 2025. Among them Vietnam, Malaysia and Thailand are also leading producers of farmed shrimp.

After China, Japan is also a key market for farmed shrimp in the Asia/Pacific region, though consumption is gradually declining. During January-July this year, the market imported nearly 117 574 MT of shrimp, in which 25% was processed products supplied by Vietnam, Thailand, Indonesia and China. This trend continued in August and is expected to persist till the year-end high consumption season in December/January. Shrimp imports in Korea Rep, Malaysia, Taiwan, Hong Kong and Singapore are largely directed to domestic consumption, whereas imports in Vietnam and Thailand are primarily reprocessed for export.

Outlook

The low production season of farmed shrimp in Asia begins in November and will continue till February 2026. During this period local supplies in China and Southeast Asia will be sold in the domestic and regional live and fresh shrimp markets at high prices. At present large sizes head-on vannamei (20-30pc/kg) are sold at US\$ 12-15 per kg in Southeast Asia's retail trade.

In China, frozen shrimp imports are likely to increase during the winter months, where competition will be strong from Ecuador.

However, for the traditional exporters to the US market, the coming months will be the testing periods particularly for exports from India, Indonesia, Vietnam, and Bangladesh.

Global trade of canned and processed fish

The international trade of canned and prepared fish (HS 1604) sustained a positive growth trajectory during the first half of 2025 compared with the same period in 2024. Imports during this period reached 1.99 million MT, valued at US\$ 9.36 billion - representing year-on-year increases of 2.05% in volume and 2.74% in value in comparison.

In total trade of HS 1604, canned and processed tuna (HS 160414) had a 42.28% share in quantitative imports and 49% in value, year on year.

Among other fish species, imports rose moderately for canned sardines and canned mackerels, while declining for canned herrings, salmon, eels, and anchovies.

In the export trade, the supply of canned fish was largely dominated by China, Thailand, Ecuador and Spain, which together accounted for 58.21% of total exports. Within this category, canned and prepared tuna (HS 160414) was the leading product group, followed by canned sardines and canned mackerels.

In the import trade, tuna once again emerged as the most popular product group, with the USA, European Union and Japan as the leading import markets. However, there is a growing demand for premium, gourmet-quality canned sardines and mackerels in the Asia Far East; most of which are imported from Europe.
